### 1. PRODUCT DESCRIPTION:

Swage fittings, types: CC, XC and XX

#### 1.1 Design:

Metal sealed swage type compression pipe couplings with body and press ring made of carbon steel or stainless steel.

Type CC: (body and press ring of carbon steel)

Type XC: (body of stainless steel and press ring of carbon steel)

Type XX: (body and press ring of stainless steel).

### 1.2 Range:

### 4. APPLICATION / LIMITATION:

- 4.1 The fittings may be used for piping systems onboard ship:
  - Firefighting systems (e.g. watermist systems)
  - Domestic fresh water
  - Sanitary / drain / scupper
  - Sounding / vent
  - Inert gas
  - Non essential systems.
- 4.2 Assembly instructions given by the manufacturer are to be complied with.
- 4.3 In all cases, the associated pipes are to be suitably supported and anchored. The joints are to be at any time accessible, excepting inside tanks where permitted by the BUREAU VERITAS Rules.
- 4.4 The use of the swage fittings for flammable fluids (flash point > 60 °C) is to be restricted on case by case ship basis.

# **5. PRODUCTION SURVEY REQUIREMENTS:**

- 5.1 The products are to be supplied by the **HAELOK AG** in compliance with the type described in this certificate.
- 5.2 This type of product is within the category HBV of BUREAU VERITAS Rule Note NR320 and as such does not require a BUREAU VERITAS product certificate.
- 5.3 **HAELOK AG** has to make the necessary arrangements to have its works recognised by BUREAU VERITAS in compliance with the requirements of NR320 for HBV products.
